

QRT in Louisville


- First iteration was a collaboration of LMPD & Centerstone Behavioral Health Services
- Barriers to this model
- Dr. Foley-Byard developed an innovative proposal to house QRT in the health department
- KRS218A.133 allows emergency services share data with the health dept
- QRT in LMDC

Stats & Data


- Partner with EMS, local authorities & hospitals
- Received over 2,500 referrals since 7/21, attempted to visit each person
- 1,830 in 2022 as of 12/21
- Connected with over 300 patients and over 400 family members
- Distributed over 700 units of Narcan
- Referred 53 people to treatment
- 2176 have gone with EMS




Redlining in Louisville



Overdose Deaths (Count) Jefferson County




Nonfatal Overdose by Drug Type (per 100,000 population), Jefferson County





Harm Reduction

"A set of practical strategies and ideas aimed at reducing negative consequences associated with drug use. Harm Reduction is also a movement for social justice built on a belief in, and respect for, the rights of people who use drugs"

Harm Reduction Approach

Utilize a Harm Reduction approach to the community

- Meet people where they are at but don't leave people where they are at
- Justice and human rights
- Instill positive change
- Free from judgment, coercion, discrimination
- Does not require anyone to stop what they do

Harm Reduction in the field

- Narcan (naloxone)
- Fentanyl test strips
- Sterile injection supplies
- Safer using practices, overdose prevention & linkage to services
- MOUD

Peer led team....Pros

- Compassionate, empathetic approach through lived experience
- Immediate reduction in stigma and shame
- Less threatening than law enforcement
- Community partner network
- Perspective people with lived experience bring to the work

Peer led team...Cons

- Vicarious trauma
- Lack of resources such as data tracking, access to databases or getting warrants redocketed
- Missed opportunity for improving police relationships with the public

Vicarious Trauma



Substance Use Vs. Substance Use Disorder

- Not all QRT clients have SUD
- Most residents report a one time use
- Example: Took a bad Xanax, needs information about mental

health treatment and safer drug use

Partnerships

- Hospitals, treatment facilities, emergency services, behavioral health services and community centers
- Foster genuine, honest and compassionate relationships for our community and residents
- Two way trust system
- Treatment facility tours, Narcan training, table events, school health fairs, LMDC
