Making Drug Seizure Data Actionable to Engage Communities and Reduce Overdoses

In 2021, the overdose death rate surpassed 107,000, with over 65% attributed to fentanyl, and despite a 50-fold increase in fentanyl seizures, there has been limited success in reducing fatal overdoses, as evidenced by a recent study indicating a rise in non-fatal overdoses following drug seizures; thus, frontline police officers have a significant opportunity to save lives by addressing supply and demand-related factors in drug use and overdoses, and this presentation will explore recent and upcoming research on the impact of drug seizures on overdoses while discussing promising practices to mitigate overdoses after legal and illicit market disruptions.

- 1.Describe recent and upcoming research associating large drug seizure data with immediate increases in overdoses.
- 2. Describe the function of the Opioid Rapid Response Program (ORRP) model for prescription opioid disruptions and understand how the rapid response model might be applied to illicit market disruptions.
- 3. Define promising practices in law enforcement to engage communities after a large drug seizure. Panelists will be able to describe how to integrate clinicians and people in recovery and with police efforts to support those suffering from addiction.

Harm Reduction: Undoing What We Know

This presentation emphasizes the need to challenge deeply ingrained ideas and beliefs, encouraging self-reflection on one's reactions to harm reduction practices and medication-assisted treatments; it delves into the history and evolution of harm reduction, dispels common stigmas, and provides practical ways to apply its core principles in various treatment settings for fostering recovery and minimizing risk.

- 2. Analyze some of the reasoning and evidence against three of the main stigmas against harm reduction and treatment with medication.

Compliance is Do-able: Sharing Protected Information in Deflection Initiatives

Multidisciplinary deflection teams actively engage people with addiction with services, including harm reduction, treatment, and peer support - instead of arrest. These initiatives demand ongoing team communications between systems and stakeholders. Understanding how HIPAA and 42 CFR Part 2 apply to this work can be confusing, leading stakeholders to refuse to join the team or teams disregarding individual privacy protections in the interest of "doing the right thing." Neither is ideal.

In this presentation, participants will gain the knowledge, tools, and practice pointers needed to support operational best practices while also successfully navigating the current and upcoming privacy compliance environment.

- 1. Understand HIPAA and Part 2 regulations.
- 2. Apply a framework to identify situations requiring legal privacy compliance.
- 3. Discuss privacy implications in deflection work and prepare for upcoming legal changes, exploring best practices for documentation ensuring privacy protection, compliance, and effectiveness.

Combatting Fatal Overdoses: What's Worked in Hamilton County, Ohio

Since 2017, Hamilton County's overdose deaths have decreased by 24%, thanks to the Hamilton County Office of Addiction Response's strategic deflection programming that employs six deflection pathways to refer individuals to a collaborative, co-responder intervention involving law enforcement and peer navigators. This initiative creates community-based pathways to treatment, recovery support services, housing, case management, or other needsbased services. In an upcoming session, presenters will discuss the initiative's development, data collection, and success metrics, emphasizing the innovative approach to identifying and coordinating services in target areas.

- 1. Understand the impact of a data-driven and multidisciplinary approach to combating fatal overdoses.
- 2. Gain insights into the six deflection pathways and their role in referral sources for the co-responder program.
- 3. Learn about the process of identifying and cataloging services in target areas, as well as creating a coordinated pathway to care by leveraging and maximizing outreach data.

DFCA's 5-part strategy includes drug testing, rewards, teen leaders, parent engagement, and education, offering a scalable, turn-key approach validated through independent evaluations, aligning with well-respected behavior theories and boasting over 70,000 memberships to date. Explore the program's journey, impact, and key success indicators in an insightful discussion.

Hamilton County Public Health collaborates with individuals with lived experience to educate local fire department/EMS staff, addressing substance use disorder stigma, providing streamlined community resources, and fostering open dialogue to support first responders in connecting individuals with treatment and recovery services.

Handle with Care

This session offers innovative best practices for helping to mitigate the negative effects experienced by children's exposure to traumatic adverse childhood experiences. It will highlight the West Virginia Handle with Care Initiative between first responders, schools, and mental health providers. Handle with Care provides the school with a "heads up" when a child has been identified by first responders at the scene of a traumatic event. Schools are responding with support and interventions to help mitigate the negative effects of the trauma on the child's wellbeing as well as their ability to learn. Therapists co-locate at the schools to provide accessible mental health services with parental permission. Handle with Care programs promote safe and supportive homes, schools, and communities that protect children, and help traumatized children heal and thrive.

- 1. Increasing awareness of the incidence and nature of Adverse Childhood Experiences in our community
- 2. Increased understanding on how trauma, ACEs, and complex trauma impacts a child's ability to learn, form relationships and function appropriately in the classroom and childcare settings.

This breakout session highlights the significance of accessing medication-assisted recovery through telehealth, addressing challenges related to the end of the public health emergency and proposed DEA changes for telehealth. It emphasizes the positive outcomes achieved through peer support via telemedicine, showcasing case studies and data on presentism, length of stay, and patient outcomes with buprenorphine. The session also introduces the Quickstart method, allowing patients to initiate Suboxone via self-administered naloxone, eliminating the need to wait for severe withdrawal, all conducted through video conferences with providers.

Learning Objectives:

- 1. Develop a comprehensive understanding of medication-assisted recovery through telehealth, including its importance and advantages; analyze challenges associated with the conclusion of the public health emergency and proposed DEA changes for telehealth; and compare treatment outcomes between in-person and telemedicine approaches.
- 2. Gain insights into the outcomes of peer support via telemedicine, utilizing case studies and data to assess factors such as presentism, length of stay, and overall effectiveness for patients receiving buprenorphine through telemedicine; additionally, evaluate the outcomes of treating pregnant women with Suboxone compared to Subutex.
- 3. Evaluate the significance of peer supporters possessing a minimum of five years of professional experience in the field and define the importance of ensuring accessibility to Suboxone in rural areas.

Cordata, a community navigation platform, was developed by and for pre-arrest deflection programs to help communities gather information easily. The platform allows for programs in different pathways to easily communicate with each other and work collaboratively toward a shared goal. Through Cordata, teams organize their workflows and improve the efficiency of collecting data. Being HIPAA and 42 CFR compliant, Cordata simplifies data sharing, making it easy for different programs and stakeholders to communicate with each other. Housing deflection data in one place allows us to work with the State as well as researchers on standardized data and data definitions. Collecting unified data around deflection will allow us to standardize data and accurately depict the impact of deflection teams from a statewide perspective.

Virginia, a leading advocate and educator, testifies before local, state, and federal agencies, Congress members, senators, and governors nationwide, remaining unwavering in her commitment to preventing further unnecessary injuries and deaths from illicit fentanyl poisonings.



Operation BRIDGE

Operation BRIDGE integrates law enforcement and substance use treatment resources to concurrently address supply and demand issues, prioritizing treatment for eligible individuals. The operation encompasses two key components: Significant Arrest Notification, where law enforcement alerts local outreach programs about drug-related arrests or large drug diversions, prompting proactive outreach efforts, naloxone distribution, and education initiatives. The second component, Narcotic Enforcement Saturation with Outreach, involves a collaborative, intensive 2-day effort by federal, state, and local law enforcement to enforce narcotic laws, focusing on drug suppliers. Concurrently, state and local recovery resources form outreach teams to aid those with substance disorders, utilizing Quick Response Teams for proactive interventions, including naloxone distribution, education, facilitating treatment, and hosting prescription pill take-back events.

Compassionate Healthcare for Those Who Use Drugs: Bridging Gaps through Syringe Services Integration

In the summer of 2022, a survey conducted by Hamilton County Public Health (HCPH) on SAFE Services participants revealed a complex relationship with healthcare providers, with health care ranking as the second-highest source of stigma. Recognizing the need for compassionate, stigma-free healthcare options, a partnership was formed in 2023 between Cincinnati Health Network (CHN) and HCPH. The collaboration aims to enhance access and engagement in healthcare services for syringe services program (SSP) clients. By co-locating HCPH's S.A.F.E. Services van and CHN providers, immediate referrals for critical health needs are facilitated, addressing the underserved population's healthcare challenges and contributing to the reduction of overdose fatalities and complications of chronic diseases.

- 2. Understand the role of health care workers in providing medical support to participants accessing SSPs, including wound care, conducting screenings, and referrals to address areas of need

Although first responder deflection initiatives focused on responding to community opioid use have historically been started and led by law enforcement, the number of fire and emergency medical service-led deflection efforts has grown. Community paramedicine through fire and emergency medical services departments are playing a pivotal role in addressing the opioid crisis through post-overdose outreach initiatives that respond to individuals after a nonfatal overdose. These programs have increasingly included the use of community paramedics and have also been providing critical lifesaving intervention in the form of medications for opioid use disorder. This panel will highlight two community paramedicine programs.

We prioritize financial literacy classes to equip participants with skills for managing their increased pay as Peer Recovery Specialists (PRS). Additionally, we offer bi-weekly group sessions where current and past participants share personal experiences with substance use and mental health struggles, fostering an open dialogue that also addresses compassion fatigue in the field.

Empowering Families in Addiction

Families dealing with addiction often find themselves overwhelmed by their loved ones' behavior, and the common advice to "detach with love" may feel unnatural and ineffective. This presentation introduces the Invitation to Change approach, rooted in evidence-based models like CRAFT, Motivational Interviewing (MI), and Acceptance and Commitment Therapy (ACT). Unlike traditional methods, this approach empowers family members to engage with love, recognizing that "all behaviors make sense." Participants will explore communication skills that motivate their loved ones to seek treatment, without resorting to judgment, shame, yelling, or ultimatums. Join us to delve into the principles of Invitation to Change and acquire effective communication strategies for engagement and motivation.

Enhancing Community Engagement and Problem Solving: The Role of Community Advocate in Delhi Police Department

This session highlights the successful implementation of the Community Advocate role in the Delhi Police department from March to December 2022. The Advocate facilitated over 900 interactions, engaging with diverse community groups and providing targeted support to vulnerable individuals. Through active engagement, critical connections to wrap-around services were established, ensuring focused assistance. The session emphasizes how this role strengthens trust, collaboration, and problem-solving between the community and the police, creating a safer and more inclusive environment. The Community Advocate's integration has proven effective in connecting individuals with essential services, overcoming community barriers, and highlighting the significance of community engagement for a safer, more supportive community.

- 1. Comprehend the day-to-day responsibilities of a Community Advocate in the Delhi Police, emphasizing their role in reducing follow-ups and repeat calls compared to traditional officers, showcasing the advantages of specialized community-focused support.
- 2. Recognize the benefits and positive outcomes for both the community and the agency resulting from increased community contacts and success stories facilitated by the Community Advocate. Highlight the value of having a non-uniformed/civilian employee dedicated to community engagement.
- 3.Evaluate the importance of social work knowledge and qualitative skills in the Community Advocate position. Acknowledge their ability to establish critical connections to wrap-around services, overcome barriers to resource access, and provide targeted assistance to individuals with pressing needs, ultimately enhancing the overall well-being of the community.

Aimed at law enforcement presence in drug and alcohol education, DREAM ensures safety for undercover officers while providing an educator-friendly series on drug and alcohol prevention.

Ultimately, the session serves as a valuable opportunity for participants to deepen their expertise in the vital domains of community safety and well-being.

- 2. Review the History and Background of the Situation Table Model.
- 3. Learn core terms and principles of the Situation Table, including Acutely Elevated Risk (AER), Risk Factors, Risk, Tracking Database, and Table Participants.
- 4. Understand the skills necessary to implement a Situation Table successfully.

This breakout session guides participants on utilizing the relink.org database, a free online resource with over 14,000 community resources in all 88 Ohio counties. The session provides insights into accessing and navigating the database efficiently, including how to quickly locate resources, list and update organizational information, and engage in local community efforts. The relink.org database covers diverse areas such as addiction recovery, reentry, anti-human trafficking, mental health, basic needs, housing, and family support. Attendees will learn how this tool can save time and facilitate individuals in finding the assistance they require, with over 119,000 Ohioans having used the relink.org database in the previous year.

With 20 hours on the van and 20 hours dedicated to field follow-up, the program extends care beyond the initial contact, enhancing its impact. The session will delve into harm reduction material distribution, screening tools, and real-time connections with resources, showcasing the collaborative efforts between the Quick Response Team and Hamilton County Public Health. Participants will gain insights into the transformative potential of embedding peer support services within SSPs, fostering a culture of care and empowerment for individuals in need.

- 1. Understand the importance of embedding peer support services within Syringe Services Programs (SSPs) to address social determinants of health and enhance the overall effectiveness of harm reduction efforts.
- 2.Recognize the role of peer navigators in providing comprehensive support to individuals accessing SSPs, including distributing essential resources, conducting screenings, and initiating appropriate referrals to address identified areas of need.
- 3. Explore the potential impact of peer support services in promoting engagement, retention, and improved health outcomes for individuals affected by substance use disorders, with a focus on reducing stigma, fostering trust, and facilitating holistic recovery.
